Jim is restricted to a wheelchair. I said restricted to a wheel chair and not limited by it. Jim displays more can do and will do spirit than a lot of people without any physical limitations. Speaking at the October VFW meeting in Marion, Jim commented on how proud he was upon hearing of his selection to participate in the hunting trip. We offer congratulations to Jim on his selection and the antelope he was able to kill, from his wheelchair, at a distance of 300 yards.

PRESIDENT SIGNS BILL AMENDING VFW MEMBERSHIP QUALIFICATIONS

Opens Door to Hostile Fire and Imminent Danger Pay Recipients

Washington, D.C. Oct. 18, 2002—The Veterans of Foreign Wars of the United States today announced that President Bush has signed legislation amending the veterans organization's congressional charter to extend membership eligibility to members of the armed forces who receive hostile fire or imminent danger pay.

"It's not about membership numbers," said VFW Commander-in-Chief Ray Sisk on the charter change, which will open doors to membership for thousands of service members, including those serving overseas in the war against terrorism. It is about doing what is right. We have long fought for this, and it is especially relevant today with so many young men and women in harm's way."

Membership in the elite organization previously had required a service member to serve in a war zone or receive an occupation, campaign, expeditionary medal or combat action ribbon.

The bill, which now becomes Public Law 107-242), was signed by the President Oct. 16. Representatives Chris Smith and Lane Evans introduced the bill, with support from Representatives George Gekas and James Sensenbrenner, as well as Senators Charles Schumer and Patrick Leahy.

Many veterans, especially those of the sea services, were exposed to asbestos during the middle decades of this century. Due to long latency periods, some lung cancers (specifically mesothelioma) may be directly related to in-services exposure. ARRANGING BURIAL IN A VA NATIONAL CEMETERY

- Burial in a national cemetery is open to all members of the Armed Forces and veterans having met minimum active service duty requirements and having been discharged under conditions other than dishonorable. Their spouse, unremarried widow or widower, minor children, and, under certain conditions, unmarried adult children, are also eligible for burial. Eligible spouses may be buried, even if they predecease the veteran. Members of the reserve components of the Armed Forces who die while on active duty or while performing training duty, or who have 20 years of service in reserve components of the Armed Forces creditable for retired pay, may also be eligible for burial.
- Gravesites in Department of Veterans Affairs (VA) national cemeteries cannot be reserved in advance. However, families are encouraged to prepare in advance by discussing cemetery options, by collecting the veteran's military information, and by calling the cemetery where burial is desired prior to the time of need.
- VA will provide a gravesite, graveliner, headstone or marker, Presidential Memorial Certificate, U.S. Flag, perpetual care of the gravesite, and will open and close the grave at no cost to the veteran's family. Services provided by funeral directors and other related costs, usually including transportation of remains, must be paid for by the veteran's family.
- VA's Veterans Benefits Administration pays a burial and plot allowance to those veterans eligible by law. For information, please contact the nearest VA regional office at 1-800-827-1000.
- The veteran's full name; rank; branch of service; date of entry and discharge; serial, social security and VA claim numbers; date and place of birth; and, date of death should be provided, if possible, to establish eligibility for burial in a VA national cemetery.

- A copy of the veteran's official military discharge document with the character of discharge is also required. If this document is not available a copy may be obtained from the National Personnel Records Center, Military Personnel Record's Office, 9700 Page Boulevard, St. Louis, Missouri 63132-5100. This should be done prior to the time of need.
- At the time of need, a funeral director or the next of kin should contact the national cemetery where burial is desired.
- The same procedures are followed if the veteran's eligible spouse or dependent predeceases the veteran. In most cases, one gravesite is provided for the burial of all eligible family members and a single headstone or marker is provided. When both spouses are veterans, two gravesites and two headstones or markers may be provided if requested.
- Upright headstones are standard in most national cemeteries, however, some have both upright headstone and flat marker sections. Be sure to discuss these options with the cemetery director prior to burial.
- The Department of Defense (DOD) is responsible for providing military funeral honors. The DOD program, "Honoring Those Who Served," calls for funeral directors to request military funeral honors on behalf of the veteran's families. Veterans' organizations may assist in the provision of military funeral honors. In support of this program, VA national cemetery staff may assist to coordinate military funeral honors.
- Funeral services are not held at national cemeteries, but a final committal service may be performed at the cemetery. For safety reasons, these services are held in committal shelters located away from the gravesite. Burial will take place following the committal service. Immediate family members may be allowed to view the actual burial only if arrangements have been made in advance with the cemetery director.
- National cemeteries do not usually conduct burials on weekends or Federal holidays. A weekend caller will be directed to one of three offices that remain open to schedule burials for the upcoming week.
- Floral arrangements may accompany the casket or urn and will be placed on the grave after burial.

THE VIETNAM VETERAN AND AGENT ORANGE

Anyone who served in Vietnam is presumed to have been exposed to Agent Orange, a herbicide that was used extensively in Vietnam to kill unwanted plant life and to remove leaves from trees, which otherwise provided cover for the enemy.

Who is eligible? All service members who served in Vietnam.

What am I eligible for:

- Free medical care to Vietnam veterans with any health problems, which may have resulted from Agent Orange exposure.
- Special compensation for 10 diseases associated with Agent Orange exposure:
 - Chloracne
 - Hodgkin's disease
 - Multiple myeloma
 - Non-Hodgkin's lymphoma
 - Porphyria cutanea tarda
 - Respiratory cancers (lung, bronchus, larynx and
 - trachea)
 - Soft-tissue sarcoma
 - Acute and subacute peripheral neuropathy
 - Prostate cancer
 - Diabetes mellitus

In addition, monetary benefits, health care and vocational rehabilitation services are provided to Vietnam veterans' offspring with spina bifida, a congenital birth defect of the spine. What is the Agent Orange Registry Physical Examination - In 1978, the VA set up a register of Vietnam veterans who were worried that they may have been exposed to chemical herbicides. Any veteran who had active service between 1962 and 1975 and who expresses a concern relating to exposure to herbicides may participate in the registry. Eligible veterans should contact the nearest VA medical facility for an appointment.
