Post 4667 Veterans Memorial

The Veterans Memorial to be constructed at the Post home will become a reality. In a near unanimous vote at the November 6th membership meeting funding was approved for the construction of the memorial. The project was awarded to Mr. William (Bill) R.White, AIA, who submitted a bid of \$148,000.00. A groundbreaking ceremony for the memorial was held November 11th, Veterans Day. Construction is scheduled to start in December. The memorial has a projected completion date of May 1st, 2004. A dedication ceremony for the memorial is scheduled to coincide with Memorial Day.

The memorial will be constructed at the corner of VFW Post property near the Goolsby Street parking lot entrance. As pictured below the memorial will be a total of 58 feet long. There will be a center building, 10 feet wide, with two equal walls of 24 feet in length extending from each side of the center building. Each side wall will be 9 feet at the highest point and extend downward to a height of 5 feet. The entire front wall of the memorial will be covered in Black Wave granite, which is quarried in Virginia. The center building has four columns constructed of Rockville Beige granite.

Carved in the wall behind the center building will be:

"This monument is dedicated to all those who served with honor in the United States Armed Services by VFW Post 4667. You will not be forgotten"



The names of veterans who honorably served in the U.S. Armed Forces are to be placed on the front of each of the side walls. Anyone wishing to have a veterans name placed on the memorial should complete and return the VFW Post 4667 Memorial Name Application. *Any* U.S. Armed Forces veteran, regardless of where they live, are eligible to have their name placed on the memorial. For a veteran to be eligible for their name to be placed on the memorial, the veteran must have honorably served in the U.S. Armed Forces. The memorial is to honor all veterans. There is a fee of \$50.00 for each name to be placed on the memorial. When completing the application please be accurate in the spelling of the veteran's name.

In order to ensure that only the names of U.S. military veterans are placed on the memorial, we are requiring verification that the person whose name is placed on the memorial is currently in or has served honorably in the U.S. military. It is the responsibility of the person applying to provide an adequate form of verification so that eligibility can be determined. Some examples of acceptable forms of verification are: DD-214 (Discharge papers), veteran's organization membership card (i.e. VFW, American Legion, etc.), photograph of service member in uniform with other service members, photo of service members name on a monument or memorial.

You must attach a form of eligibility to this application.

Applications without a form of verification will not be processed.

All payments by check should be made out to "VFW Post 4667" and on the memo line please indicate "VFW Memorial".

Donations to help with the construction and maintenance of the memorial are welcomed. All donations to the project are tax deductible. You can indicate the amount of donation on the front of this form or mail your donation to the VFW. Please indicate on the check memo line "VFW Memorial Donation".

"I believe in the United States of America as a government of the people, by the people, for the people; whose just powers are derived from the consent of the governed; a democracy in a republic; a sovereign Nation of many sovereign States; a perfect union, one and inseparable; established upon those principles of freedom, equality, justice, and humanity for which American patriots sacrificed their lives and fortunes." I therefore believe it is my duty to my country to love it, to support its Constitution, to obey its laws, to respect its flag, and to defend it against all enemies."

William Tyler Page, Clerk of the U.S. House of Representatives, wrote "The American's Creed" in 1917. It was accepted by the House on behalf of the American people on April 3, 1918.

VA TO FILL PRESCEIPTION BY NON-VA PHYSICIANS

WASHINGTON, July 24, 2003– Some veterans waiting to see Department of Veterans Affairs (VA) physicians for the first time may be eligible to receive medications from VA mail-out pharmacies that were prescribed by private doctors, under a new policy announced today.

"This policy should ease the minds of veterans with pharmaceutical needs who have been waiting too long for their first appointment," said Secretary of Veterans Affairs Anthony J. Principi. "This decision will help these veterans while preserving our ability to serve others."

To be eligible for the new benefit, veterans must meet all of the following conditions: Have enrolled in VA health care before July 25, 2003, and Requested their first primary care appointment with VA before July 25, 2003, and Must be waiting more than 30 days for their first appointment with a primary care physician on Sept. 22, 2003.

The first prescriptions will be filled under the new program on September 22. Eligible veterans will be unable to get prescriptions filled before that date. The period between announcement of the program (July 25) and filling the first prescriptions (Sept. 22) is necessary to allow VA to identify and contact eligible veterans and to put new systems and procedures in place to deliver this benefit.

Principi stressed the policy is a short-term measure to assist veterans who were enrolled and waiting for the appointment before July 25, when details about the new benefit were published in the *Federal Register*. It will not apply to veterans who are put on the waiting list after July 24. VA estimates that 200,000 veterans will be eligible for the benefit.

"Traditionally, an examination and a prescription – both by a VA physician -- have been required before VA would provide pharmacy benefits to veterans," Principi said. "By improving the process of giving veterans the medication they're seeking, we can enhance their health care treatment and reduce the waiting lists for everyone."

Veterans covered by the new rule will receive information by mail from their nearest VA medical facility about filling prescriptions by mail from non-VA doctors, including information for the doctors themselves.

Principi credited Reps. John Mica (R-Fla.) and Rob Simmons (R-Conn.) with "playing an important role in launching this new benefit due to their keen interest in improving prescription coverage for veterans."

Online Registry for World War II Veterans Available

Registry Honors the Generation that Defended the Nation's Founding Principles in History's Largest War

Washington D.C., August 6, 2003--At a time when fewer than one in ten adults recognize that 16 million Americans served in uniform during the Second World War, the American Battle Monuments Commission (ABMC) has introduced a World War II Registry online to document the names of those who participated in history's largest and most devastating war.

The Registry is accessible on the National World War II Memorial website (http://www.wwiimemorial.com/default.asp?page=registry.asp&subpage=intro).

Any American that served in the armed forces or contributed to the war effort on the home front, whether in factories and shipyards or farms and neighborhoods, is eligible.

There is no charge to place a name in the Registry. Individuals can be enrolled through the web site or by calling the memorial's toll free number at 1-800-639-4WW2.

The Registry contains more than one million records, most submitted by the public. The database also includes National Archives and Records Administration lists of those killed in service during the war and names of those buried in ABMC overseas cemeteries or listed on its Tablets of the Missing.

There is no charge to enroll a member of the WWII generation in the Registry, although there is a \$5 processing fee for a certificate of the enrollment and a \$10 fee to add a photograph of the individual to the record.

The memorial is under construction and on schedule for the official dedication ceremony set for Saturday, May 29, 2004. The Registry will be accessible at the memorial site on the National Mall when the memorial is opened to the public.

Of 1,002 U.S. adults responding to a phone survey in May: 22 percent believed that only 100,000 served in uniform during the war, 34 percent thought one million served, 14 percent thought 8 million served, just 8 percent correctly stated 16 million, and 22 percent didn't know.
