Veterans Memorial

At the July 2002 VFW meeting, Commander Bill Sword appointed the following Post members to a Veterans Memorial committee: John Arthur, Thomas Bartlet, Henry Brant, Algie Crouse, Claude Dean, John Harmon, Herbert Hart, Roger Haulsee, Roy McNeil, Andy Snow, John Taminger, Cecil Carter and Marshall Guy (chairman).

Two sub-committees were set up: 1) Site Committee, chaired by Roy McNeil, to look for a site to construct the memorial, and 2) Design Committee, chaired by Roger Haulsee, to design the memorial. After looking at several sites in the Marion area, the site committee

recommended that the memorial be built on the southwest corner of our parking lot, adjoining Goolsby St. and the Earnest property. Since this property is located in the county and zoned residential, we had to apply for a special use permit to build on this location. This took two months to file the application and submit it to the planning commission. The planning commission approved our request and on March 11, the Board of Supervisors also approved the request.

We then applied for a variance to the setback requirements of the zoning ordinance from 60 ft to 30 ft. The Smyth County Board of Zoning Appeals denied our request at the May meeting of the Board of Supervisors. The setback distance was changed from 60 ft. to 40 ft. After the change in setback requirements, we were back in business and the Design Committee met with Bill White, our architect, who is working on details for the monument. We are hoping to give a complete detail of the memorial at the July meeting.

POST 4667 AWARDED THE 2002 Jennifer C. Byler Award Of Excellence

The Post received a letter dated April 28, 2003 from the Stanley J. Lapekas, Executive Secretary, Commonwealth of Virginia, Charitable Gaming Commission. In part the letter reads:

"The Virginia Charitable Gaming Commission (the "Commission") is please to announce that your organization is the recipient of a 2002 Jennifer C. Byler Award of Excellence (the "Byler Award"). The Byler Award recognizes qualified permitted charitable gaming organizations for their outstanding quality of service to both their organization and community, and their efforts toward enhancing the image of charitable gaming in the Commonwealth of Virginia. In addition, the Byler Award also recognizes the outstanding social services provided by these organizations, and their ability to provide services to people and organization in need – the true goal of charitable giving. Of course, the Commission also recognizes that these goals could not be attained without talented members who volunteer their services and time, and who contribute enormously to charitable causes.

I am extremely proud and grateful for the dedication that each organization has demonstrated toward their communities. It is endearing to see people pull together to help someone pay their utilities when on is struggling with either a health or financial crisis, to pay for repairs to a vehicle so that someone who needs transportation for medical services can keep their medically important appointments, and donate monies to a transitional housing facility for homeless to self-sufficiency. These are just a few of the wonderful examples of the charitable work that your organizations have performed for the period October 1, 2001 through September 30, 2002.

It is also important and worth noting that your organization and its members are also setting an example for others, particularly children, on what it means to make a commitment to people and communities or through monetary contributions."

Our membership for the coming year has been set at 1014. With *YOUR HELP*, we can reach this quota by January 2004.


